The subject of teacher placement after September 30 - Erin Felker has drawn up a letter to send to the SD and KTTA and other pertinent parties they address this issue. Their feeling is that our children are not from having a change in teacher after the first month of school. system is creating a lack of faith in the principal's organizational priorities. The SD process - The estimated next year's enrolment dictates the budget for teachers. September 30th is when the actual count of enrolment is finalized. The report then goes to the ministry of education and funding goes through. Will will ask Dr. Sullivan on Friday's meeting, how the assignment process works.

This topic is tabled till the next meeting, at which time a draft will be discussed, voted on, and drawn up.

Trustee Remarks:

BC Ed Plan - asking for input into curriculum and grad program. There was a committee of 60 looking into feedback to decide on draft for curriculum. The goal is to be less specific but more goal oriented (outcome based) Assessment methods are also being looked at. The goal is that the same child will be assessed by more than one teacher at the same level. This allows needs targeting.
