### **Graduation Portfolio**

Ross Spina, Assistant Superintendent – Secondary Education presented information regarding

- **2006 Regional Portfolio Review Forum** available Thursday, Oct.26, Ramada Lodge Hotel, 2170 Harvey Ave., Kelowna, B.C.
- The Graduation Portfolio 2006-2007 can be a "standing granted" or "credit with grade application to grade twelve accomplishments".
- The Grade 12 student, this year, decides to complete their "Graduation Portfolio" Assessment, or not, in the beginning of the school year.
- Some schools have reported initial participation rates as;

 Sahali 41/137

Action: Ross Spina will query schools to assess percentages of female and male students opting to complete portfolios.

Sahali secondary councilor submitted information regarding some reasons students had opted to complete or not complete:

Those choosing to complete the portfolio (approx. 30%) gave the following reasons:

- 1. They had already done a lot of work and wanted to finish for personal satisfaction.
- 2. They wanted a high mark on their transcript.
- 3. They were in a special Portfolio group in gr.11 and wanted to finish with the group. Students that chose not to continue (approx. 70%) gave reasons as follows:
- 1. They want to concentrate on their academic subjects.
- 2. They think that most universities will not be counting the portfolio mark.
- 3. They have no time; many grade 12's are balancing school/homework, job, and sports.
- 4. They have not fully embraced the project and feel ambiguous about finishing.

<u>Class Size and Composition</u> resource information presented by Ross Spina as per the "Superintendent's Report" attached to last meetings minutes. The data will be submitted for the District Template. Information on every class will be available. The "Class Size" data will be published for the public by October 31, 2006. There are ten senior classes with more than 30 students enrolled. Consultation has occurred between teacher, principal and school board in these situations (Leadership, Music, PE classes).

# **School Fees**

Lesley summarized what she heard Dr. Terry Sullivan present Monday night at the School Board meeting:

- Recent legal action does not prohibit education fees but further restricts education fees.
   There is no Ministry statement to date. Unlikely to be appealed. No additional funding available.
- Two committees will be struck. One to work with the information each Principal is submitting regarding listing all fees in each school. The same Committee will assess the cost to the Board to absorb this year's fees that can no longer be charged, and suggest a process of approval for the paying of these fees.
- The second Committee will assess what can be charged and what will be restricted. This may incorporate the restructuring of some programs and/or the elimination of other programs.
- Dr Sullivan states a letter will go out early in the New Year to each parent and child. He requests that we continue to be patient and that there be no disruption to the programs this year.

### Discussion

- Fees are not allowed for curriculum/courses that contribute to graduation (electives included)
- Concerns regarding two tier education systems because of economic demographics

- Concerns regarding "demonstration only" classes.
- No definitive plan on this years paid fees.
- Discussion regarding the power of parents and students to influence government. Discussion regarding "early intervention" and "timing" being critical. Perhaps the DPACs throughout the province would communicate.
- Paula requesting the opportunity for parent input into second committee outlined by Dr. Sullivan at board meeting.

#### Action:

Paula to forward Victoria DPAC interpretation synopsis to DPAC distribution list.

Paula to query provincial DPAC list-serve to discuss provincial parent voice and possible action.

Gisela Ruckert, Paula Schmidt, Dean Watts and Lesley Davidson to draft a one page resource letter outlining background information, interpretation, possible questions for PACs to consider, and possible opportunities for action.
